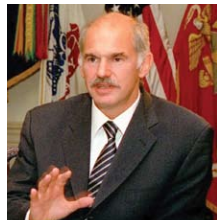

Focusing on the overarching theme '**Vision for a Sustainable Tomorrow: business as a game changer,**' the Forum will deliberate on the following sub-themes.

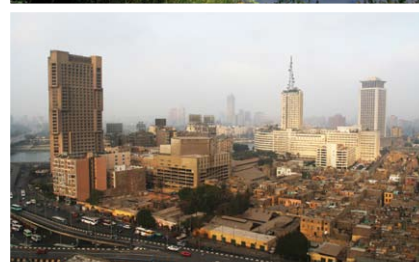
