

Purpose of Workshop

The purpose of the DRM workshop is twofold, namely:

- To provide practical skills for Humanitarian/Relief practitioners who are involved in the Risk Reduction, Emergency Response and/or Recovery Initiatives in Disaster Risk Management (DRM) situations
- To provide practical skills for Humanitarian/Relief or Development Practitioners who are involved in the development and implementation of Disaster Risk Management Plans (DRMPs) from local up to national levels

The workshop will look at global best practice in both DRM and the development and implementation of DRMPs. This is aimed at governmental, non-government organisation (NGO), Red Cross, UN and other stakeholder personnel. It will draw down on lessons learnt from both Australian DRM situations (eg bushfires, Cyclone Larry), and also major overseas situations, in particular the 2004 Indian Ocean Tsunami.

Who is this course for?

This workshop is primarily designed for people across the humanitarian to development spectrum, and in previous workshops, participants have come from the following:

- Non-Profit Organisations (NGOs), Community Based Organisations (CBOs) and the Red Cross
- Government departments or government-funded bodies
- UN agencies and bilateral funding agencies
- International Private Development Contracting companies
- Tertiary Institutions and Individuals (Volunteers, Consultants, Students)

Skills Taught/Methodology

After an initial introduction to DRM, the range of practical skills required to prepare practitioners for DRM initiatives at different levels will be introduced using a combination of adult teaching methodologies. The focus will very much be on Risk Reduction, although lessons learnt from the Emergency Response and Recovery stages of major disasters will also be covered. A field visit will take on the afternoon of the second day to see how government departments and community groups maximise risk reduction initiatives along the bushfire-prone Otways region along the Surf Coast shire.

The Trainers

This DRM workshop will be facilitated by Chris Piper, the TorqAid Director. Chris has run his consultancy TorqAid since 1992, and has facilitated the DRM workshop, or variants of this, in Sri Lanka, Bangladesh, Indonesia (Aceh), Lao PDR, the Marshall Islands, Singapore, Australia, South Africa, Madagascar, and the UK. He will be assisted by Stephen Young FAIM, who is coming down from Queensland. A senior emergency manager of 26 years international experience, Stephen led the Queensland Government's response to the 2006 Tropical Cyclone Larry


