The Western States Water Council, and the California Department of Water Resources in cooperation with the Western Governors' Association are cosponsoring a workshop on the National Integrated Drought Information System (NIDIS) reauthorization on September 24-26, in San Diego, California.

The purpose of the workshop is to examine topics that the Council or Western Governors' Association may wish to emphasize in potential congressional reauthorization of NIDIS. For example, seasonal to inter-annual drought prediction capability is a high priority for Western water managers, and a subject presently lacking a focused federal research effort. The impacts of this summer's unexpected severe drought in the Midwest highlight how valuable predictive capability would have been.

The workshop will begin Monday, September 24 at 1:00 pm and conclude Wednesday, September 26 by noon. A block of rooms has been reserved and will be held through September 3.
