# Who Does What Where Exercise in Disaster Risk Reduction in Bosnia and Herzegovina

### **FOREWORD**

Since the catastrophic floods in May 2014, disaster risk reduction (DRR) has gained increased attention in Bosnia and Herzegovina. A number of government institutions, international agencies, scientific organizations and non-governmental organizations are currently in the process of scaling up their DRR programming.

DRR is a cross-cutting issue that relates to development and emergency programming. It requires public awareness, scientific knowledge, community participation, political commitment, supportive legislation, urban planning, technical advice, geospatial risk assessments, building codes, lines of communication, early warning systems, and effective emergency preparedness, disaster response and recovery mechanisms. Close collaboration of policy-makers, scientists, urban planners, engineers, architects, development workers and civil society is a precondition for adopting comprehensive approaches and inventing new solutions. Multi-stakeholder and inter-agency platforms can help mobilize knowledge, skills and resources required for mainstreaming DRR into development and emergency policies, plans and programmes by providing coordination, analysis and advice.

Since DRR requires new collaboration patterns among a wide range of participants, one of the key challenges is to obtain an overview of who does what where in the field of DRR in Bosnia and Herzegovina. For this reason, UN in collaboration with the Ministry of Security and the Embassy of Switzerland in BiH launched a 'who does what where' exercise on the International Day for Disaster Reduction, 13 October 2015. Guidelines and questionnaires were disseminated to participants of the multi-stakeholder meeting. Afterwards, other DRR practitioners submitted their profiles to become part of the first inter-agency mapping exercise.

Although this first version remains a working draft, we hope the institutional/organizational profiles will facilitate better coordination among DRR stakeholders in Bosnia and Herzegovina. In order to provide an accurate picture of the evolving DRR scenario in the country, this publication should remain a living document requiring continuous review and updating. Information included in the publication is shown as received from the partners and the content is the responsibility of each organization. However, the profiles were edited to comply with the guidelines and ensure consistency across the institutions/organizations. Special thanks go to those who responded and ensured that their information was up to date.

### **GENERAL AGENCY PROFILE**

Aarhus Centre in Bosnia and Herzegovina was originally established as part of the OSCE project, in cooperation with the City of Sarajevo, in May 2012. In early 2013, the Centre transformed into a non-governmental organization. Its mission is to provide help to authorities to fulfil responsibilities set in the Aarhus Convention, promote the introduction of regulations and methods aimed at providing access to information, public participation and access to justice in environmental matters and act as a conduit between the administration, civil society and public in general. ### DRR AGENCY PROFILE

In past one year through the project "Strengthening the capacities of Aarhus Centers in DRR in order to enhance awareness of communities" we have organized workshop in Zenica to upgrade knowledge of Aarhus Centers and their partners from NGO sector and municipalities about DRR concepts and approaches, to facilitate exchange of experiences among DRR experts and practitioners and to define priority actions and cooperation modalities of Aarhus Centers, municipalities and other stakeholders related to DRR. Through the same project we have developed an Action plan for strengthening public awareness of DRR in Vogosca together with relevant stakeholders and created posters with alerting signs and actions to be taken by citizens in cases of emergency. Within the project for the promotion of the International Day of DRR, we have prepared and printed schedule for students in elementary schools. We also produced a brochure on natural hazards, floods and landslides and we have organized two workshops about DRR, one with local communities and second with media representatives from Vogosca. In the future we would like to implement other activities from mentioned Plan.



### GENERAL AGENCY PROFILE

Caritas Switzerland (CaCH) has had a continuous presence in Bosnia & Herzegovina since 1995. Since then the organisation invested an amount of over USD 60 million through various projects and programs related to emergency rehabilitation and long term development. ### DRR AGENCY PROFILE

DRR is an integral part of CaCH projects and programs. In the sector of agriculture, through its long term programs in B&H, CaCH significantly reduced socio-economic vulnerabilities of smallholders to disasters and the effects of climate change. Transforming farmers from sustenance to commercial agriculture significantly improved their responsiveness and resilience to natural disasters and strengthened their livelihoods. Additionally CaCH reduces minorities' vulnerability to disasters, such as Roma communities by promotion of inclusion in preschool and adult education but especially through a durable housing program for the Roma, having a significant impact on the disaster resilience of former slum dwellers. Through projects in energy efficiency on public and household levels, CaCH reduced the use of wood as heating material, conserving natural resources and by that reducing natural degradation leading to mudslides. In the event of severe natural disasters such as the more recent floods in B&H, CaCH also responds with measures that aim at longer term disaster resilience, such as durable housing and drinking water supply.



Activities of the CPA RS in the field of DRR prescribed by the Law are: providing the Protection and Rescue Programme and the Programme for Natural and Other Disaster Reduction in the RS. in line with strategic documents in the field of DRR, following, harmonizing and implementing relevant policy and guidelines, ensuring compliance with laws and other regulations in the field of civil protection in the protection and rescue system, establishing methodology for conducting risk assessments and other documents that belong to the Plan of protection and rescue against natural and other disasters. Programme of protection and rescue is responsible for training and equipping civil protection staff at the level of the Republic of Srpska, collecting and analyzing data on all types of phenomena and hazards that may result in natural and other disasters, organizing and implementing activities of monitoring, informing and warning, implementing plans and programmes for training, provides experts assistance to protection and rescue actors, providing instructions and guidelines for civil protection services of the local communities, participates in protection and rescue actions in case of natural and other disaster, orders implementation of readiness measures, concludes contracts on engagement, etc.



### DRR AGENCY PROFILE

CRS started its DRR program as a disaster response to flooding in May 2014. Reinforcements and upgrading was executed in repair of existing structures to become more resistant and resilient to damaging effects. In addition to this, a set of workshops has been conducted with key stakeholders in five municipalities, aiming to develop programs and plans (preparedness, contingency) for critical facilities leading to strengthened capabilities to prevent and respond to disasters. CRS implemented these activities under USAID-funded Community Economic Strengthening through Action (CESTA), which is composed of 26 medium infrastructure projects, 26 small infrastructure projects and DRR activities related to DRR municipal trainings and development of Flooding Prevention Plans for key municipal infrastructure institutions. Some of the implemented measures, which will come as a result of developed Prevention plans, would be jointly implemented with key institutions. In coming period CRS will continue to work in five municipalities to develop a Municipal DRR/M Action Plan, which would be partly budgeted in municipal annual budgets based on clear priority.



### DRR AGENCY PROFILE

Dutch Risk Reduction Team (DRR Team) is team of 3-5 experts that advises governments on how to resolve urgent water issues related to flood risks, water pollution and water supply, to prevent disasters or to rebuild after water related disasters. BiH MOFTER submitted request for DRRT assistance and it is expected that mission (7-10 days) should take place in March 2016. The Government of the Kingdom of the Netherlands provided contribution through the Dutch Red Cross to the International Federation of the Red Cross (IFRC), implemented by the IFRC and Red Cross partners in BiH. This contribution amounts: EUR 210.000, - (IFRC Appeal) + EUR 40.000 for the DREF. It was focusing at providing primary help to the floods-affected persons with their return to their homes, and after that on providing them with livelihood support. In cooperation with NWP (Netherlands Water Platform) and BiH MOFTER Ministry of Foreign Trade and Economic Relations) the Embassy organized a seminar "Dutch solutions for water problems" focusing on: flood risk management; early warning system and solutions for waste water on 31 March 2015.

### **GENERAL AGENCY PROFILE**

The Programme for Prevention, Preparedness and Response to Floods in the Western Balkans and Turkey (the "Programme" or "IPA FLOODS") - funded by the European Commission DG ECHO through the Instrument for Pre-Accession Assistance (IPA) - is intended to increase beneficiaries' capacity to ensure proper flood risk management at national, regional and EU levels. IPA FLOODS is composed of two closely interrelated Lots. Lot 1 started on 1 January 2015 and running until 31 December 2016 has a budget of almost 2 million EURO and is aimed to: a) increase beneficiaries' capability to develop effective national civil protection systems and collaborate in a coherent manner in dealing with floods at regional/European level; b) support beneficiaries in becoming better prepared to cope with the challenges posed by approximation to/implementation of the EU Floods Directive. Lot 2 - started in July 2015 with an implementation period of 30 months and a budget of almost 4 million EURO - is aimed to contribute to increasing beneficiaries' capability to develop effective national civil protection systems and collaborate in a coherent manner in dealing with floods at regional/European level (prevention, preparedness and response).

IPA FLOODS supports capacity building (including the provision of equipment and training) for flood response preparedness through the establishment of multinational Civil Protection Modules for "Flood Rescue using Boats" (Lot 1), "High Capacity Pumping" and "Flood Containment" (Lot 2) in line with the requirements for Civil Protection Modules set forth under the Union Civil Protection Mechanism. In this context, the Programme promotes also the development of models of protocols for border-crossing and Host Nation Support according to the EU Guidelines on Host Nation Support. Furthermore, IPA FLOODS plans to organize two regional field-exercises for the multinational Civil Protection Modules with participation of Civil Protection Modules of the same type from the Participating States of the Union Civil Protection Mechanism. The Programme delivers also a capacity building programme for further implementation of the EU Floods Directive in the beneficiaries, including the development of guidelines on flood risk management which take stock of existing EU/national guidelines/guidance documents for the implementation of the EU Floods Directive and refer to all relevant requirements, stakeholders, challenges and indicative general costs in addressing the EU Floods Directive

Functionally, it is linked to Framework law on the Protection and Rescue of People and Property in the event of Natural or other disasters in BiH. 



The objective is the establishment of a NATO-compatible BiH defence and security establishment under democratic, civilian state-level command and control, with full transparency and oversight, within a governing and institutional framework that is acceptable to NATO from the perspective of inviting BiH to join the Alliance.

NHQSa is working with the Ministry of Security, the Civil Protection Administrations, the Ministry of Defence and AFBIH on improving the BiH Civil Emergency Planning system and in particular the coordination and cooperation among various actors in BiH. After the 2014 floods, NATO HQ sent an expert team to assess the BiH Protection and Rescue system and provided recommendations, later on discussed in a Lessons Learned Conference in November 2014. The current activities are dedicated to improve civil-military cooperation during natural or man-made disasters, increase joint trainings between civilian authorities and the AFBIH, increase implementation of the Framework Law on Protection and Rescue and other relevant documents and plan future NATO exercises in BiH, including a civil emergency planning element.

The Agency is responsible for the following tasks: organizing, collecting and distributing the data on water resources in accordance with the regulations of the Law on Water, including establishment and maintenance of the water management information system, organizing hydrological monitoring and monitoring of the quality of waters, monitoring of the ecological state of the surface waters, reporting on the state of waters and recommends necessary measures, preparing water management plans for the basin, organizing preparation of technical documentation for relevant water management issues, and other water management tasks in accordance with the Law on Waters; preparing plans for the prevention of floods and decrease of damages caused by floods and droughts and organizing their implementation, undertaking urgent measures for prevention or decrease of harmful effects of pollution incidents and preparing plans for those events, participating in policy development for the water sector and waterrelated legislation, raising public awareness on sustainable use of water, water protection and protection of water ecosystems.



Sava River Watershed Agency, Sarajevo, is in charge for implementation of the active defense measures against floods and ice in the imminent danger of floods and during floods, as well as for the post-floods consequences elimination. The Agency implements the following flood defense activities: organizing implementation of defense measures against floods and ice in the territory of the Federation BiH, assigning authorized legal entities for implementation of the defense measures against floods and ice in flooded areas equipped with flood control facilities, preparing full reports with general data about the system of flood control facilities in flooded areas for presentation to the Federal Ministry of Agriculture, Water-Management and Forestry and Federal Civil Protection Administration; preparing annual reports about floods and flood and ice defense activities in flooded areas, conducting regular inspection of riverbeds to ensure controlled and harmless flow of water in flooded areas along surface waters of the 1st category. Until now we have completed preliminary assessment of flood risks in the Sava River Basin in the Federation BiH for the 1st category watercourses, and prepared and adopted methodology for development of disaster and risk maps.





The training programme introduces an integrated approach to DRR and a shift from primary focus of disaster response to preparedness and mitigation approach. With regard to harmonizing DRR aspects into cantonal and local development strategies, a methodological guide was prepared providing practical steps on how to integrate DRR aspects in strategic planning processes. Following the agreement on the methodological approach, mainstreaming of DRR aspects was initiated in the ongoing strategic planning processes in 7 cantons as well as in 13 local governments that have initiated revisions of their development strategies (particularly those that were most severely hit by the floods.



**GENERAL AGENCY PROFILE** 

The Swiss Red Cross has a long history of providing assistance in Bosnia and Herzegovina. It started 1992 with the support of the war affected population with emergency relief supplies through the network of the International Committee of the Red Cross. After the end of the war 1995, the SRC concentrated its aid efforts on reconstruction and rehabilitation of schools and hospitals, provision of psycho-social support to refugees and internally displaced persons living in collective centres and organising training programmes for auxiliary nurses. The Home Based Care and Active Ageing project focuses on 3 main intervention axes; elaboration of an affordable model of home based care and assistance for elderly and disabled people, auxiliary to the provision of the Ministry of Health, with the possibility to replicate in the future to other areas of Bosnia and Herzegovina, contribute to the integration and participation of elderly in the society. The project purpose is to increase access of vulnerable elderly and disabled people to home based social and medical care; to increase the integration and participation of elderly in the society and improve the knowledge on healthy ageing and prevention of chronic disease among the population.

### DRR AGENCY PROFILE

The Swiss Red Cross immediately responded to the 2014 flooding with its office based in Tuzla by providing emergency and early recovery relief to the affected population through the local RC branches of Maglaj, Doboj, Šamac, Orašje, Brčko District of BiH, and Bjeljina. Since August 2014, through the RC of Šamac, Orašje, Domaljevac and Odžak, SRC implemented the Flood Recovery Project providing cash assistance to 1.326 households. The financial means provided, allowed the vulnerable flood-affected families to cover the costs for basic repair of, in average, two rooms and for essential household needs such as heating material, electricity, health or furnishing. RC branches from Domaljevac, Orašje and Šamac established volunteer pools with special functions in emergency response teams. The purpose of the project "Community-based Disaster Risk Management" 2015-2017, is to build up the disaster risk management model in Šamac, Orašje and Brčko District of BiH. On the municipal level, the aim is to enhance coordination and cooperation mechanisms between all relevant stakeholders responding during emergencies (Civil Protection Department, Fire fighters and RC).

This focuses on sources of data, their strengths, shortfalls and uses, and provides a list of vital indicators that could be used to better appraise risks and vulnerabilities, and identify target populations and institutions for more effective DRR strategies.



### **GENERAL AGENCY PROFILE**

In 1992, at the request of the UN Secretary General, UNHCR was designated as the lead agency for humanitarian efforts during the conflict in Bosnia and Herzegovina, overseeing one of the largest relief operations ever organized. In the period between 1992 and 1995, UNHCR's multi-sectoral assistance, in one form or the other, helped over 2.7 million beneficiaries, 80 per cent of the then population. Annex VII of the Dayton Peace Agreement specifically mandated UNHCR to assist the BiH authorities in finding durable solutions for all those who were displaced. Twenty years later, with UNHCR mobilizing over one billion dollars in the country, concerted national and international efforts, in particular regarding improvements in security, the repossession of property and the reconstruction of houses, have enabled more than a million refugees and internally displaced people (IDPs) to exercise their right to return. UNHCR is working in close partnership with local authorities, NGOs and international actors to achieve solutions for the remaining refugees and displaced persons from the 1991-1999 conflicts in former Yugoslavia. For new arrivals, the organization is working with IOM and an intra-ministerial group under a regional initiative on asylum and migration, with the aim of strengthening reception conditions and refugee status determination procedures, and reducing the use of detention for asylum-seekers.

Currently, UNHCR does not have any specific programme in the field of DRR in Bosnia and Herzegovina but stands ready to actively participate in any activity related to prevention and awareness raising alongside other partners and placing emphasis on protection needs of displaced population resulting from a disaster. Within the IASC's cluster approach UNHCR will take the lead of the protection cluster and, if required, in partnership with IFRC and IOM, UNHCR will be engaged in the shelter and camp coordination and camp management clusters.
